## Work on project to expand & upgrade Cedar River Car Wash now underway

Work on a project to expand and upgrade the Cedar River Car Wash is now underway. The facility is located on Cedar River Drive, west off South Grand Avenue in the Village of Fowlerville.

Matt Martin, who owns the business, said that the finished product will offer a new cleaning option for customers. "We'll be adding another 4,000 square feet to the building, doubling its size" he explained. "It'll include a 120-foot tunnel wash on the west end where we'll install high-pressure water nozzles and foam fingers that, by using friction, will do a better job of removing dirt and grime. We'll also have

## Contested races in Primary election brought out large number of voters

Contested races in last week's Michigan Primary election brought out a large number of voters both in Livingston County and across the state.

On the Republican side, Bill Schuette—the current Attorney General—easily won his party's nomination for Governor, topping three other candidates including Lt. Gov. Brian Calley. John James, meanwhile, won the GOP vote to run for the U.S. Senate, while incumbent Republican Congressman Mike Bishop had little trouble beating his primary opponent for the 8<sup>th</sup> District House seat.

Closer to home, Lana Theis—the current Republican state representative for eastern Livingston County—topped her GOP opponent in the 22<sup>nd</sup> District State Senate race by a two-to-one margin. County-wide, she received 21,089 votes

employees prepping the cars as drivers enter the bay.”

The car wash already has three self-serve wash bays and two touchless automatic bays.

Plans also call for upgrading this existing equipment, installing a new water-treatment system that uses fresh water, and putting in new floors.

“It'll be almost like a brand-new car wash,” Martin pointed out.

The initial timetable called for work to commence at the end of May, but a need to address wet soil and other unanticipated hurdles pushed back the start date. But those issues have been addressed and grading work—including hauling in extra fill soil—was in full swing last week. Martin estimates the work will take around eight weeks to finish with the end of October being the goal. He added that while the car wash was still open last week during the site preparation phase, the scope of the project will require that the facility be closed during most of the construction.

The engineer for the project is Monument Engineering of Fowlerville, while J. Rajala Construction is the general contractor. Other, local sub-contractors are being used in the construction and renovation.

Martin, who also owns Old Glory Auto Wash on Grand River, four miles east of Fowlerville, purchased Cedar River Car Wash in 2009.

to Joseph Converse Marinaro's total of 6,135. That district covers all of Livingston County, plus the western part of Washtenaw County.

State Rep. Hank Vaupel, the GOP incumbent for the 47<sup>th</sup> District that includes the Fowlerville area was unopposed in the primary. He garnered 11,638 votes.

Doug Helzerman, the current Republican county commissioner for the 4<sup>th</sup> District that covers western Livingston County, topped his GOP opponent, Christopher Maloney by a 1,679 to 768 margin. In the neighboring 6<sup>th</sup> District that covers part of the Howell area, incumbent Robert Bezotte won the primary over his Republican foe, Steve Williams by a 2,015 to 1,232 margin.

On the Democratic side, Gretchen Whitmer—a former state legislator—won her party's nomination for Governor, beating two opponents. For the U.S. Senate seat, Democratic incumbent Debbie Stabenow was unopposed in her bid for re-election.

Also unopposed on the Democratic Primary ballot were Adam Dreher, the candidate for the 22<sup>nd</sup> District State Senate seat; Colleen Turk, the candidate for the 47<sup>th</sup> District State House seat; and Maureen Martin, the candidate for the 4<sup>th</sup> District of the county board of commissioners.

One of the more hotly-contested races—appearing on the non-partisan portion of the ballot—was for the new judgeship on the Livingston County 44<sup>th</sup> Circuit Court. The Michigan Supreme Court and legislation had previously dictated that the county needed to add a third judge to the Circuit Court and eliminate one of its three District Judge positions.

Four candidates filed for the eight-year term—all of them Howell area residents.

L. Suzanne Geddis, a current District Court Judge, topped the field with 11,177 votes, while Dennis Brewer finished second with a total of 10,100. They now move onto the November General Election.

Eliminated were Monica Copeland who placed third with 8,528 votes, followed by Tara Pearson who had 4,170 votes.

Also on the ballot were several millage propositions.

The Handy Township request for a four-year renewal of its one-mill levy for road maintenance and dust control, starting in 2019, was approved with 696 ‘yes’ votes to 160 ‘no’ votes.

The Village of Fowlerville sought to renew its levy for the Mosquito Abatement Program and voters approved the measure by a 338 to 70 margin.

Cohoctah Township also had a road millage renewal on

the ballot and that proposal was approved with 619 ‘yes’ votes to 145 ‘no’ votes.

The Fowlerville Community Schools, meanwhile, asked district voters to approve an 18-mill non-homestead property tax renewal for another four years. That request was successful with a 1,914 to 929 margin.

### Cops vs. Robbers vs. The Media

On Aug. 12, 1658, the first formalized police force in America was established in New York City. Law enforcement now exists at all levels of government and for all manner of public safety interests.

Local sheriffs help keep the peace and manage day-to-day needs, state police coordinate efforts to tackle statewide trends in crime, and federal agencies like Immigration and Customs Enforcement help to protect our national sovereignty and fight back against the wave of human and drug trafficking that ruins so many lives.

Most people, thankfully, have very little interaction with police officers: perhaps only when they get pulled over or when they need to report a crime. But anyone who spends time with law enforcement officers knows the service and sacrifice these men and women give to our country every day.

The demands of law enforcement require that these officers put their lives on the line to keep their neighbors safe. Every year more than 120 officers die in the line of duty and many more are seriously injured. Because of the hazardous and demanding nature of the job, officers often have health issues like cardiovascular disease, lack of sleep and stress disorders. Imagine having that nervous feeling when you get pulled over 14 times during a 12-hour shift!

The countless stories of heroism and bravery from our law enforcement officers are sadly ignored by most mainstream media. Instead, our cops are demonized as brutes, racists or murderers. The anarchist and communist groups that defame our police like this are twisted individuals. When they malign our police officers and our justice system they are not only attacking the good people in uniform, but they are attacking law and order itself.

I encourage you all to reject these anti-law-and-order attitudes. Instead, meet with your local police to learn more about what they do and the challenges they face. Go for a ride-along, attend a community discussion group, or patronize a police fundraiser.

## Drifting Away from God

Read Hebrews 2:1-3.

In one of my devotions a few weeks ago, the author shared a story about how he and a friend came across an abandoned boat drifting down the river. They managed to retrieve the boat and, even though there were only a couple of broken paddles in it, they decided to get in and shove off.

As they talked and joked around, the boat slowly drifted along with the current, they were not focusing on time or where they were going. They realized they were in trouble when they suddenly heard this loud roar. They looked up to see the water up ahead of them and saw the water rushing over the dam.

Fear seized them. Quickly they grabbed the broken paddles and began to row against the current. Luckily for them, they managed to get close enough to shore and shallow water so they could step out and walk to safety. As they turned around and looked back, they saw the boat go over the dam and heard it crash on the rocks below.

“That is the danger of allowing ourselves to drift along in our Christian faith. What begins as fun and pleasure ends up in shipwreck because people drift along, neglecting to think ahead or notice how fast they are moving away from the safety of the Lord’s plan” (Charles Stanley, The Danger of Drifting.)

My question for you this week is: “Are you navigating a course that leads to Jesus or are you simply drifting along to where-ever the current takes you?”

Hebrews chapter one, verse one, says: “We must listen very carefully to the truth we have heard, or we may drift away from it.” Drifting away from God becomes easier with each compromise we make in our daily routine to neglect our spiritual disciplines, that keeps us on course in our quest to be obedient to the will of God.

Signs of drifting begin when we start to skip our daily Bible readings. Which leads to skipping our times of prayer and meditating on His word. Before long we are skipping church to pursue other interests that appeal to our human hunger for fun. At first we only miss one Sunday every now and then, but if we’re not careful, we will find ourselves skipping two and three Sundays at a time. If we don’t take the corrective measures and refocus our attention on God and what He desires for us, we will find ourselves neglecting Sunday worship altogether.

When we allow ourselves to focus on anything other than God, we are in danger of drifting away from the purpose and path that He has laid out for us. The author of Hebrews tells us to pay closer attention to the truth. The truth we have read in the scriptures. The truth we have heard from our pastors and Sunday school teachers, our mentors and others who are walking down the path that leads to eternal life with Jesus.

“For the message God delivered through angels has always stood firm, and every violation of the law and every act of disobedience was punished. So what makes us think we can escape if we ignore this great salvation that was first announced by the Lord Jesus himself and then delivered to us by those who heard him speak? (verses 2-3)

One thing you can be sure of is this. “If you are drifting away from God, it is your enemy the devil that is luring you away.” “Stay alert! Watch out for your great enemy, the devil. He prowls around like a roaring lion, looking for someone to devour.” (1Peter 5:8)

The devil never sleeps and he always attacks you at your weakest point. For instance, he knows I am an alcoholic. He also knows that once I begin to drink, I cannot stop. So when I vowed to give up drinking, he did everything he could to draw me back into the bottle.

The way I resist the temptation to drink is by staying focused on God and staying connected with others who are fighting the same battle as I am. I can resist any temptation that comes at me by the power of Jesus that resides inside of me. But if I am not engaged in regularly disciplined time of Bible reading, which will lead to a neglected prayer life, my resistance to the attacks of the devil, will not be strong enough for me to resist and I will succumb to his tactics and be drawn into doing something I don’t really want to do.

The apostle Paul put it like this. “I love God’s law with all my heart. But there is another power within me that is at war with my mind. This power makes me a slave to the sin that is still within me. Oh, what a miserable person I am! Who will free me from this life that is dominated by sin and death? (Romans 7:22-24)

God can, God will, and God has! There is no power in existence that is able to compete with the power of God. How do we keep our way pure? How do we avoid drifting away from God? How do we stand firm and remain faithful to Him? We simply keep our minds on Jesus and obey the truth of the scriptures, which is God’s Holy Word.

Sometimes we don’t realize we’re drifting away from God. The process begins with the smallest compromise. Something that doesn’t seem to be significant. But that compromise makes it easier when the next temptation comes along that tries to entice us to choose other interests over God. Before long it gets easy, and we justify our neglect with excuses that we dream up to satisfy our conscience. Which doesn’t always work because our conscience knows what is really happening.

By the way, Sunday is not the only time we neglect God. When our interest in other things becomes more important than seeking after God, we are in danger of drifting away. We should be nurturing our spiritual minds every day—through Bible reading, praying, and worshipping Him in voice and heart with other believers.

Take a little time to examine your daily routine and see if you’re drifting away from God. Check out your top priority in life. If it is not seeking after God, your priorities are out of

order.

If you find that you are drifting, grab a Bible and paddle (read) yourself back on course.

# Michigan House Report

The Michigan Department of Health and Human Services (MDHHS) issued a warning to not consume fish caught between the Huron River at Milford to the Huron River at Base Line and Portage lakes. This is due to elevated levels of perfluoroalkyl and polyfluoroalkyl substances (PFAS) and perfluorooctane sulfonate (PFOS), the latter of which was discovered in fish from Kent Lake.

Bodies of water included in the advisory are Hubbell Pond, Kent Lake, Strawberry and Zukey Lake, Gallagher Lake, Loon Lake, Whitewood Lakes, Base Line and Portage lakes. ## How Medicare Covers Diabetes

Dear Savvy Senior,

How well does Medicare cover diabetes? I'm 66 years old and was recently told by my doctor that I have pre-diabetes. If it progresses to full-fledged diabetes what can I expect from Medicare.

Dear Recently,

Medicare actually provides a wide range of coverage to help beneficiaries who have diabetes, as well as those who are at risk of getting it – but they don't cover everything. Here's a breakdown of what Medicare covers when it comes to diabetes services and supplies along with some other tips that can help you save.

**Screenings:** If you have pre-diabetes or some other health conditions that put you at risk of getting diabetes – such as high blood pressure, high cholesterol and triglycerides, are overweight, or have a family history of diabetes – Medicare Part B (medical insurance) will pay 100 percent of the cost of up to two diabetes screenings every year.

**Doctor's services:** If you're a Medicare beneficiary, Medicare will pay 80 percent of the cost of all doctor's office visits that are related to diabetes. You are responsible for paying the remaining 20 percent after you've met this year's \$183 (for 2018) Part B deductible.

**Prevention program:** Just launched in April, the Medicare Diabetes Prevention Program provides lifestyle change programs offered by health professionals to help you prevent diabetes. This is available for free to all Part B beneficiaries who have pre-diabetes.

**Self-management:** If you have diabetes, Medicare covers 80 percent of the cost of self-management training to teach you how to successfully manage your diabetes.

**Supplies and medications:** Medicare Part B covers 80 percent of the cost of glucose monitors, test strips (100 per month if you use insulin, or 33 per month if you don't), lancets, external insulin pumps and insulin (if you use a pump), after you've met your deductible.

If, however, you inject insulin with a syringe, Medicare's Part D prescription drug benefit will help pay your insulin costs and the supplies needed to inject it – if you have a plan. Part D plans also cover most other diabetic medications too. You'll need to check your plan for coverage details.

**Nutrition therapy:** Medicare will pick up the entire tab for medical nutrition therapy, which teaches you how to adjust your diet so you can better manage your condition. You'll need a doctor's referral to get this service.

**Foot care:** Since foot problems are common among diabetics, Medicare covers 80 percent of foot exams every six months for diabetics with diabetes-related nerve damage.

They will also help pay for therapeutic shoes or inserts as long as your podiatrist prescribes them.

**Eye exams:** Because diabetes increases the risks of getting glaucoma and diabetic retinopathy, 80 percent of dilated medical eye exams are covered each year, but eye refractions for glasses are not.

### Other Insurance

If you have a Medicare supplemental (Medigap) policy, it may pay some of the costs that Medicare doesn't cover. Call your plan's benefits administrator for more information.

Or, if you're in a Medicare Advantage plan (like an HMO or PPO), your plan must give you at least the same diabetes coverage as original Medicare does, but it may have different rules. You'll need to check your policy for details.

### Financial Assistance

If your income is low, and you can't afford your Medicare out-of-pocket costs, you may be able to get help through Medicare Savings Programs. To find out if you qualify or to apply, contact your state Medicaid program.

Also, find out if you are eligible for "Extra Help" which helps Medicare Part D beneficiaries with their medication expenses. Visit [SSA.gov/prescriptionhelp](http://SSA.gov/prescriptionhelp) or call Social Security (800-772-1213) to learn more.

# Lee Hamilton Column

## A More Perfect Union

You know these words, but how often do you stop to think about them? “We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity...”

They belong, of course, to the Preamble to the U.S. Constitution. That remarkable document is not just the blueprint for our political system. Its Preamble is also a profoundly aspirational call to arms. Because when you read it, it’s hard not to ask yourself how we’re doing — at establishing justice, promoting the general welfare, securing the blessings of liberty, and, in sum, creating a more perfect union.

It’s especially hard to avoid asking this question now, when the warnings of democracy in retreat are all around us. For many, the creeping authoritarianism that has taken hold in any number of countries — Russia, China, Bolivia, Turkey, the Philippines, and Hungary, among others — seems alarmingly on the ascendant.

You can also look around and find developments that make you wonder whether the world’s democracies have much cause for complacency. Worrisome environmental trends, population growth, climate change, the ills that go along with rising consumption — like mountains of trash and depletion of natural resources — all suggest a world unable to rein in its appetites.

Yet it’s undeniable that we’ve come a long way in this country and in other democracies, expanding women’s rights and the rights of minorities, ending child labor, banning nuclear testing, improving literacy, building strong economies. The world’s most vibrant economies and most nimble military forces remain mostly in the hands of democratic nations: the U.S., France, Great Britain, Germany, Japan, and Australia.

I don’t believe that people around the world favor authoritarianism. They prefer a voice in government. But most of all, they want decent lives for themselves and their children. They are not so wedded to a democratic system that if they see no improvement in their lives, they’ll reject authoritarianism. So democratic governments have to perform. They have to meet the expectations of their people and improve the quality of their citizens’ lives.

In the U.S., many Americans, worried about the direction of their country, wonder whether it is making progress toward the ideals of the Preamble. We seem to advance, fall back, and then move forward again, all in incremental steps. What do we mean when we talk about “a more perfect Union”? I suppose we think of material progress. But more fundamentally, I hope, we think about the expansion of human freedom and progress toward the goals set out simply and eloquently in the Preamble. There’s a sense that we’re all in this American experience together: it brings us together and connects us with our past, present and future.


The American experiment in representative democracy is always a work in progress. The results are always in doubt. Lincoln’s words at Gettysburg — “whether a nation so conceived and so dedicated can long endure” — will probably resonate for as long as we’re a nation.

We face immense systemic problems at the moment: racial discrimination, wage stagnation, staggering income inequality, political polarization, the pernicious effects of too much money washing around in the system, the degradation of civil discourse. It is not a given that we’ll be able to resolve them, and we always have to be alert to the fact that our freedoms and rights can be eroded. Which means that to prevent this erosion we have to step up to the task of responsible citizenship.

This is a challenge for every generation. We’ve stepped up to it in the past, through world wars, the Civil War, economic recessions and depressions. As Americans we believe in a set of democratic ideals, basic rights, fundamental freedoms, and the notion that all people are created equal and all are entitled to dignity. These are ideas that give us cohesiveness and identify us.

But we cannot take our ability to deliver on them for granted. Without a renewal of energy and commitment to the democratic values of the Constitution, without acting on the call issued by the Preamble, we could lose them.

## Michigan DNR Fishing Tip—

### Buying minnows for your next outing

Minnows are a popular bait option for many anglers, but do you know the difference between the various species? Understanding these differences can help you during your next fishing adventure!

#### Fathead

These minnows are usually one to three inches long and are available all year long. In particular, fatheads are great for targeting yellow perch in the fall and are considered excellent walleye bait as well.

#### Golden Shiner

These minnows are usually around three inches long and are effective during winter, spring and fall months. Many anglers use these minnows for targeting walleye.

#### Spottail Shiner

These minnows are usually between two and a half and three inches long and have a limited availability, usually during the spring. These minnows are great when walleye fishing.

#### Sucker Minnow

These minnows are usually between three to four inches, but they can grow to nearly a foot long. They’re available at all times during the year and are considered a top bait choice for northern pike in the summer.

Please note Michigan has several bait restrictions in place to prevent the spread of fish diseases. Information about these restrictions and regulations can be found on page 27 of the 2018 Michigan Fishing Guide.





Community input being sought for new Livingston County Transit Master Plan

The Livingston County Transportation Coalition is seeking input from community members in developing a Transit Master Plan that addresses future needs and goals in the county.

The Coalition consists of nearly 100 members, including interested individuals as well as representatives for various organizations—Chambers of Commerce, DDAs, senior centers, health care providers, human services organizations, transportation providers, businesses, planners, educational institutions, local municipalities, churches, charities, and an environmental group. It is chaired by Dr. Leo Hanifin.

Dr. Hanifin, in published comments, said that the group feels there is “a need to improve and expand transportation services locally, and is looking to carry out the collective vision by way of a master plan.”

“Its scope will be very broad and may include scheduled bus service, expanded dial-a-ride services, express computer and airport services, and a network of bike and walking trails. It will also study governance and funding options.”

The goal, Dr. Hanifin said, is to have a new transportation plan by the end of 2018.

The Transit Master Plan will be based on public input and data analysis by AECOM; a transportation consulting corporation said to be familiar with Michigan.

Community members can share their thoughts in several ways: by talking with municipal and county planners, attending public meetings focused on plan options that will be held this fall, and/or by completing a survey that is now open online at: [www.surveymonkey.com/r/livcotransit](http://www.surveymonkey.com/r/livcotransit)

The Coalition, in its news release, noted that 75 percent of county residents commute to jobs outside of the county and over 60 percent of county workers live outside the county, suggesting the need for a mass-transit option.

They further stated that every \$1 invested in public transportation leads to \$8 in economic development and that between 2000 and 2030 there will be six times as many seniors in the county.

This month, Capital Area District Libraries’ Webberville branch is launching a new ABC Table.

This is not “ABC” as in the alphabet. In this case, A is for Artists, B is for Builders, and C is for Creators. The table is our small version of a Makerspace, so that kids ages 8–18 have a place to work with hands-on kits and materials we provide.

The idea for the ABC Table came about when we noticed that some of our scheduled afterschool programs were getting harder for kids to attend. They are not always available on specific days and times. Now we can offer some self-directed activities they can do on their own schedule, during the library’s open hours.

Some of the projects kids can ask to use include potholder looms, a K’nex Maker Kit, and Perler beads. K’nex creations must stay in the library, but kids get to keep the potholders and Perler bead items they create. Since Perler bead projects need to be ironed by a staff person, the finished items get picked up later by their creators.

Some items may be used by younger children if they have parent helpers. We also have a table top paper dispenser for doodlers to use. From time to time there will be simple origami projects on display that kids can try as well.

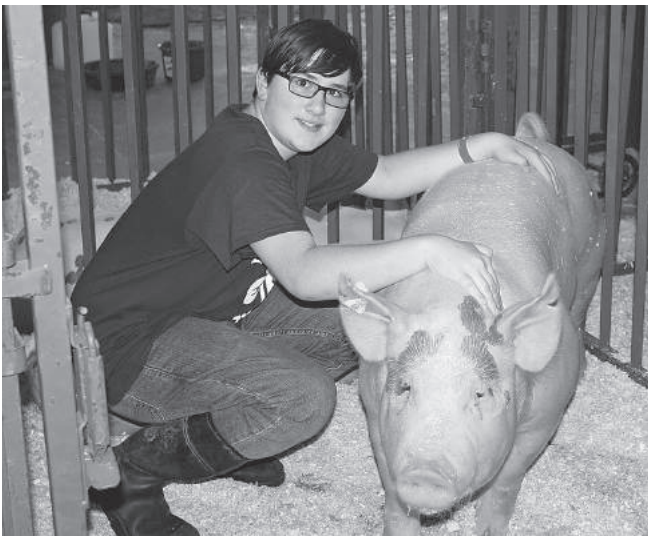

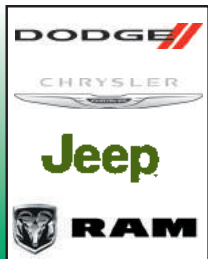
